Report of visit to Village Panchayat Poriem for training and capacity building under Gram Panchayat Development Plan

The three day visit consisted of lectures, focused group discussions, sector visits, surveys and social mapping.

The aim of the said process was:

- a. To create awareness about the village level planning process with peoples involvement.
- b. To provide information to the people on various issues and schemes.
- c. To collect data, identify problems and issues existing in the village and eventually enable the Panchayat to prepare their "Gram Panchayat Development Plan" by understanding the existing position of the village and the facilities available.

Preparatory activity:

Prior to the study visit, GIPARD had to do the following preparatory activities:

- 1. Identify a village Panchayat for conducting the situation analysis.
- 2. Circulate formats for obtaining basic data and information from the Panchayat which would help the team in conducting situation analysis and eventually in preparing the draft status report.
- 3. Prepare a detailed programme of tasks and activities, role and responsibilities of the facilitators and the trainees during the visit.
- 4. Issue letters to the Director Panchayats, BDO Sattari Taluka intimating the visit and requesting him to direct the concerned officials in the Taluka to co operate in conducting the situation analysis.
- 5. Interaction with the Sarpanch, Secretary and the elected members of Poriem Panchayat, briefing them about the visit, the activities planned through the visit and the nature of support and assistance required from the Panchayat.

- 6. Letters to the heads of the line department to intimate the staff located in the village Panchayat to support and co operate in the process.
- 7. The following assistance was required from the village Panchayat:

The Sarpanch to intimate the villagers to assemble on 02nd October 2019 at 10.00 a.m in the gram Panchayat premises.

- All the elected representatives and the Secretary to remain present.
- The committee members to remain present.
- The Sarpanch and Secretary was given a note on the FFC and the need for preparing the GPDP through peoples participation so that they could brief the people as well as circulate in the village.

During the Three days, the facilitators and the trainees would try to build rapport and create a comfortable environment by singing songs, sharing some experiences of peoples planning.

General observations on the situation analysis process:

- 1. Preparatory activities are very essential for the success of this activity.
- 2. Though the activities were well planned, however the same had to be altered or rearranged as per the availability of groups/ villagers, particularly for FGDs.
- 3. The Committee members and ERs have to remain present.
- 4. Though detailed formats were prepared by the team, it was difficult to fill in all the details due to lack of time or lack of awareness of the staff of the line departments, ERs, etc.
- 5. The people were quite excited about what was done in the three days.
- 6. More people could have participated in the process.
- 7. Awareness levels among the ERs, line depts. and the public is poor.
- 8. Participation in Gram Sabha is poor.
- 9. Display of basic information at the Anganwadis, Health Centre, PDS, etc is important.
- 10. Panchayat body has to maintain database about the revenue details, village statistics, committees, etc.
- 11. Line departments have to share data with the Panchayats on a regularly basis and Panchayat body should also ask for it, so that it is available at one point.

Problem / Suggestions

- Eight Anganwadis do not have proper kitchen facilities (room) and there is every danger of children getting hurt from knife, gas cylinder etc.
- It is observed that some of the Anganwadis need proper ventilation facilities (renovation).
- Some of the Anganwadis do not have toilet facilities, toilet facilities to be provided.
- No proper storage facilities for food items.
- Eight Anganwadis are located in private premises and the rent is paid partly by Panchayat and ICDS.
- Some of the Anganwadis have constraint of space, sanitation and need renovation or relocation.

FOCUSED GROUP DISCUSSIONS WITH FARMERS:-



Problems

- No proper water/Irrigation and electricity supply.
- Insecticides and pesticides are not provided by the government.
- Wild animals create havoc in fields.
- Barren land issue.
- No labours to carry goods from the farm.
- Lack of knowledge about different schemes in agricultural sector.

Suggestions

- Survey of barren land should be conducted.
- Supply of motor for irrigation purpose.
- Solar fencing should be done to avoid wild animals.
- Need of construction of water harvesting unit for irrigation purpose.
- Training on modern farming techniques.
- The Panchayat must make use of the MGNREGA scheme for helping the farmers in the village.
